### **Definitions**

 $\underline{F2F}$  | A regular course that meets face to face as indicated on the semester schedule.

<u>ONLINE</u> | A course that meets asynchronously via web-based technologies.

HYBRID | A hybrid course will meet face to face for a minimum of 50% of the course, i.e. students must complest 22.5 hourse of actual seat time on campus. Faculty may add a live synchronous, web-based component to the couse (not more than 50% of the course). Both face to face components and web-based delivery methods must be schedule on the syllabus.
